

## Your Rights in respect of your Personal Data

## 1. Your Rights in respect of your Personal Data and how they may be exercised

The table below outlines your rights in respect of your Personal Data that we collect process, use and store and how you may exercise such rights.

<b>Rights</b>	<b>Explanation</b>
<b>Access</b> – You have the right to access to your Personal Data including the records of any email correspondence, between you and the Company, held by the Company.	Specifically, you have the right to enquire as to whether we process any Personal Data of yours as well as which Personal Data is processed and the manner of such processing. You have the right to receive a copy of your Personal Data without any charge. <b>Rectification</b> – You have a right to rectification of inaccurate Personal Data and to update incomplete Personal Data.	In case you believe that any of the Personal Data held by the Company is inaccurate, you are entitled to request to restrict the processing of that Personal Data and rectify the inaccuracies.
<b>Erasure</b> – You have a right to request that your Personal Data be deleted.	You may request to delete your Personal Data in case you believe that: <ul style="list-style-type: none"><li>• the Company no longer needs to process your Personal Data for the purposes for which it was provided;</li><li>• the processing is based on your consent which you withdraw;</li><li>• the processing of your Personal Data is unlawful;</li><li>• your Personal Data must be raise for reasons of compliance with legal obligations;</li></ul>

<p><b>Restriction</b> – You have a right to request that we restrict the processing of your Personal Data.</p>	<p>You may request us to restrict processing your Personal Data where:</p> <ul style="list-style-type: none"> <li>• we are investigating whether any of your Personal Data held by the Company is inaccurate;</li> <li>• the Company no longer needs to process your Personal Data for the purposes for which it was provided, but you require such Data to establish, exercise or defend legal proceedings;</li> <li>• your Personal Data is processed in an unlawful manner and you chose to exercise the right to restrict processing instead of your right to deletion as set out above;</li> <li>• for a period enabling us to verify whether any legitimate interest on which we are relying for the processing of your Personal Data overrides your interest</li> </ul> <p>You may exercise this right by contacting us at <a href="mailto:dpo@gregoriou.com">dpo@gregoriou.com</a> or at +357 –22451555 or at 7 Florinis street, Greg Tower, 6th Floor, 1065, Nicosia, Cyprus.</p>
<p><b>Portability</b> – You have a right to data portability.</p>	<p>You have the right to receive your Personal Data or to request that we transmit such Personal Data to another third party (where this is technically feasible) in a structured, commonly used machine-readable format where the processing is based on your consent or pursuant to our contract with you or where processing is carried out by automated means. Where you</p>

<p><b>Objection</b> – You have a right to object to the processing of your Personal Data.</p>	<p>You have a right to object to us processing your Personal Data for marketing purposes or on the basis of the legitimate interest as described in the Section 5 of this Privacy Notice– unless we can demonstrate compelling and legitimate grounds for the processing, which may override your own interests, or for the establishment, exercise or defence of legal claims.</p> <p>The Company may need to restrict or cease processing your Personal Data altogether or, where requested, delete your information.</p> <p>Please note that if you chose to exercise this right, we may have to suspend or terminate the services provided to you.</p>
<p><b>Withdraw consent</b> – You have a right to withdraw your consent.</p>	<p>In case in which the Company relies on your consent to process your Personal Data (including Personal Data falling under the special categories), you have a right to withdraw your consent at any time by sending a written request at <a href="mailto:dpo@gregoriou.com">dpo@gregoriou.com</a> or by contacting us at +357 –22451555 or at 7 Florinis street, Greg Tower, 6th Floor, 1065, Nicosia, Cyprus.</p>
<p><b>Raise a complaint</b> – You have a right to raise a complaint with the Data</p>	<p>If you wish to make a complaint, you can contact our Data Protection Officer who will investigate the matter.</p>

<p>Protection Commissioner's Office.</p>	<p>We expect to be fully able to address any concerns you may have directly in the first instance; however we would like to inform you of your right to address any complaint to the Data Protection Commissioner's Office at any time should you so wish. <p>Not be subject to <b>automated decision-making</b> processing (including profiling) – You have the right not to be subject to automated decision making.</p>	<p>You have the right not to be subject to a decision, based solely on automated processing of Personal Data. At this point, the Company does not have in place any automated-decision making in respect of your Personal Data.</p>
